The Fund aims to provide long-term capital growth with a focus on absolute return and diversification across multiple asset classes and geographical regions.


The goal is to achieve high risk-adjusted absolute returns through a strategic asset allocation framework by replicating a US university endowment model, while also protecting capital and profit from equity bear markets through dynamic asset allocation; hence targeting riskadjusted absolute returns superior to a traditional long-only equity fund or a 60/40 balanced fund over a market cycle.

The firm's investment philosophy is to apply realworld discretionary trading strategies to the rigour of a quantitative process focusing on delivering superior risk-adjusted absolute returns.


