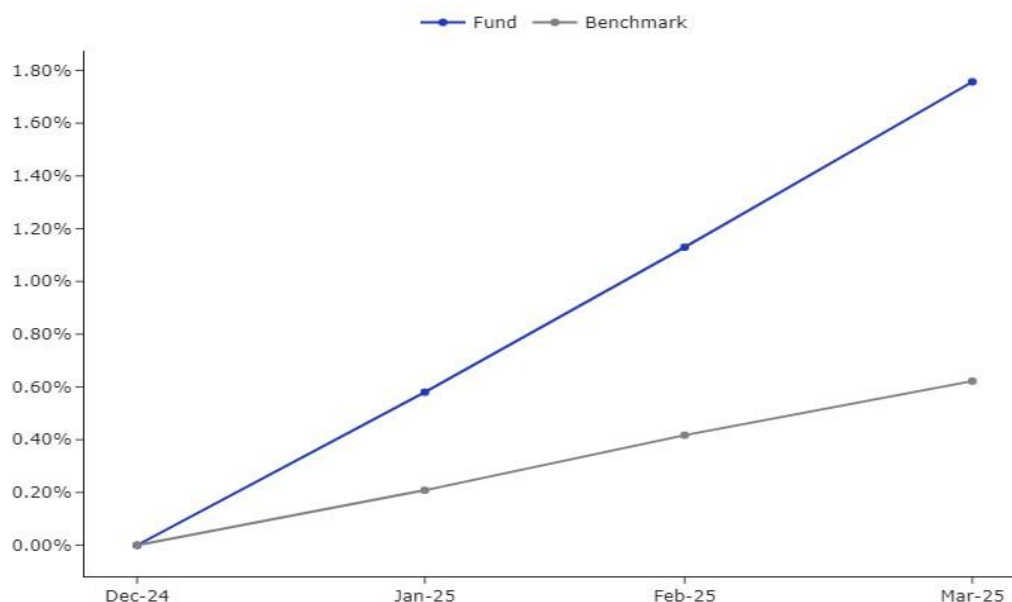


MANAGER'S STATEMENT
