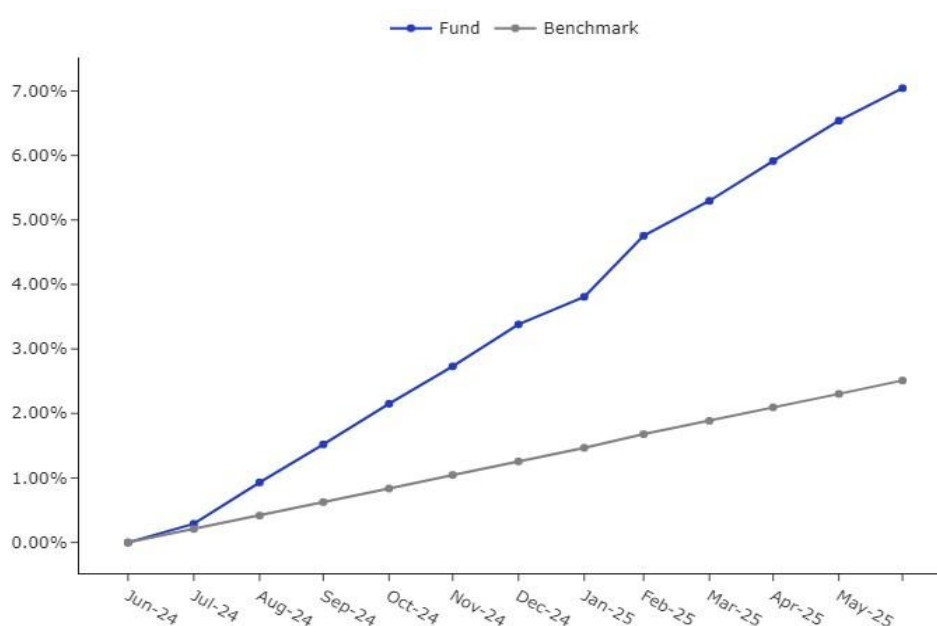

The Fund may also invest in collective investment schemes and place deposits with Financial Institutions.


MANAGER'S STATEMENT
